**Item 14. Chief Executive Officer's Report**

Chief Executive Officer Eric Stern provided the following updates:

- Mr. Stern thanked John Conneally for his service on the Board and noted that SCERS will begin working with VRE on a special election in the coming months.
- Mr. Stern reminded the Board that Form 700 are due April 1<sup>st</sup>.
- Mr. Stern reported that changes have been made in some of the consent items, including a reduced volume of material included with disability items, high-level summaries added to the portfolio rebalancing and trading cost analysis reports, a new proxy voting activity report, and a new SACRS legislative update.
- Mr. Stern reported that he will bring revisions to the CEO Delegated Authority Policy for Expenses to the Board at the March meeting.

- Mr. Stern reported that General Counsel Stephen Lau and Chief Investment Officer Steve Davis have been working on a panel discussion for the March Board meeting about fiduciary considerations for private market investments.
- Mr. Stern provided information on upcoming education conferences for Board members.
