Celebrating Older Americans Month: Powered by Connection

In 1963, responding to the needs of older Americans and the shortage of assistance programs, President John F. Kennedy designated the month of May as Senior Citizens Month (now known as Older Americans Month). Each May since then is celebrated as a time to recognize older Americans' contributions, highlight aging trends, and reaffirm commitments to serving the older adults in our communities.

These days, older Americans are working longer, living longer, and advocating for their own health and independence. However, since the pandemic, social isolation has increased, especially for older Americans, and is now being recognized as a public health crisis associated with numerous health risks.

This year's Older Americans Month theme, "Powered by Connection," focuses on the profound impact that meaningful connections have on the well-being and health of older adults.

AARP finds that the act of volunteerism provides an effective way to promote social well-being and meaningful relationships for all age groups by staying engaged with one's community through shared interests.

"New retirees can define their purpose by volunteering," said Sacramento County Retired Employees Association President Randal Angeloni. "You don't retire *from*, you retire *to*," said Angeloni, who retired in 2006 after working 32 years for the Department of General Services.

Last year, Sacramento County's Adult and Aging Commission honored several volunteers, including Howard Hatch, a Sacramento History Museum volunteer who became a TikTok celebrity during the pandemic when videos of him operating the museum's old printing press went viral. He's been volunteering at the museum for over 20 years and loves teaching younger generations about our region's history.



Investment Performance Update

SCERS is on pace to meet its annual investment target of 6.75% following a strong second quarter of the fiscal year, through December 31, 2023.

Halfway through SCERS' fiscal year, which ends June 30, 2024, SCERS has returned 3.9% net of investment management fees. For the second quarter of SCERS' 2023-24 fiscal year, through December 31, 2023, SCERS' total fund returned 5.7% net of investment management fees and finished with a market value of \$12.9 billion.


The fund continued to gain steam and surpassed \$13 billion during the third quarter, which ends March 31, 2024, though final numbers were not available by publication time.

"The SCERS portfolio is benefitting from strong tailwinds, including moderating inflation, the expectation for interest rate cuts by the Federal Reserve, and resilient economic data," said Steve Davis, SCERS' chief investment officer.

However, Mr. Davis also indicated there are risks that could affect markets, including sticky inflation, high market valuations, and the impact that higher interest rates and inflation could have on the consumer and the economy.

Over the longer 5- and 10-year periods, SCERS' net returns of 9.0% and 7.1% rank in the 21st percentile of pension funds in the U.S. over both periods.

Asset classes that are leading performance for the fiscal year include Global Equity (+6.9%), Public Credit (+5.7%), and Private Credit (+4.7%). Asset classes that have lagged include Real Estate (-5.3%) and Private Equity (+1.7%).



Reorganized Sewer District to Break From County

On January 1, 2024, the Sacramento Regional County Sanitation District and the Sacramento Area Sewer District formally merged into one district now called the Sacramento Area Sewer District or SacSewer.

After decades of operating as a Sacramento County department, SacSewer will officially separate from the County this December.

As a new employer, SacSewer will continue with SCERS, and its 730 current employees will continue to be SCERS members. SCERS is working with SacSewer and the County to ensure that the newly merged agency's current and former employees and retirees retain all the pension benefits they have earned, and that the pension liabilities of current and former SacSewer employees are adequately addressed and accounted for.

SCERS is supporting AB 2301 (Nguyen) that helps facilitate a smooth transition of pension benefits and funding between the County and SacSewer. SCERS has taken an active role in the legislation to ensure that more than \$560 million in pension liabilities and assets will be apportioned between the County and SacSewer in a fair manner that will protect the pension fund and its members in the long run and avoid potential disputes in the future over payment obligations.

The legislation also ensures that current "legacy" employees will retain their retirement benefit tier. These provisions are similar to other enacted legislation regarding consolidations or reorganizations of governmental entities in the post-PEPRA era.

SacSewer is the Sacramento region's sewage collection, treatment, and resource recovery utility-providing service to more than 1.6 million people and over 5,000 miles of pipes in our region. It is the second largest sewage collection utility in California, owning and operating the second largest water resource recovery facility of its kind in the nation.

SCERS Rolls Out Self-Scheduling Tool

SCERS is excited to announce the launch of a new feature on our website, aimed at providing you with a convenient way to interact with us.

A new webpage titled "Schedule an Appointment," accessible under the "For Members" heading, enables you to schedule either in-person or telephone counseling appointments online.

Appointments can be scheduled up to 90 days in advance or as soon as two days out, with each session allotted 45 minutes. You can also opt to call us to schedule an appointment.

We will continue to offer four counseling appointments per day (9:00 AM, 10:00 AM, 1:00 PM, and 2:00 PM) and accommodate walk-in appointments when available.



SCERS Hosts Employer Forum



In February, SCERS hosted its annual employer forum—the first in-person forum since before the pandemic—to showcase the organization's strategic priorities and provide updates on funding, investments, and member services.

Attendees at the education event included administrative staff from

the Department of Personnel Services, County Executive's Office, District Attorney's Office, Department of Finance, Sheriff's Office, Regional Parks, Department of Technology, Orangevale Recreation & Park District, Sunrise Recreation & Park District, Rio Linda/Elverta Recreation & Park District, and the Sacramento Superior Court.

The post-forum survey showed all attendees in agreement that the information was helpful. "I felt that it was informative and helpful to receive information regarding member experiences during the retirement process and the value of the pension for employees," one attendee opined.

SCERS will host its next Employer Forum in early 2025.

Alameda Corrections Are Completed

SCERS has finished recalculating the last batch of pension adjustments for County retirees.

This milestone signals the completion of a significant court-directed correction process affecting about 1,500 SCERS retirees. The median monthly pension reduction was \$10.18.

In July 2020, the California Supreme Court determined that certain pay elements were no longer allowed to be included in pension calculations. To comply with the "Alameda" ruling, SCERS corrected final compensation records back to January 1, 2013, refunding overpaid contributions and adjusting pension allowances. SCERS is also concluding its final analysis of contribution data to determine if more refunds are owed.

SCERS has refunded approximately \$3 million to more than 4,000 members, with a median refund of about \$70.


